OFFICE ORDER

Subject: Constitution of Steering Committee for Review of Pharm. D Curriculum.

The Higher Education Commission, Pakistan vide communication dated Feb 25, 2025 forwarded the draft of the Pharm-D curriculum revised in light of the recommendations of the National Curriculum Review Committee constituted by the HEC for vetting/endorsement by the Pharmacy Council of Pakistan as required under the provisions of Section 17 of the Pharmacy Act, 1967.

2. The matter was placed before the Council in its 62nd meeting, held on March 1, 2025 whereupon, after deliberations, the Council constituted the following Steering Committee of its members in exercise of the powers vested under Section 12 of the Pharmacy Act, 1967;

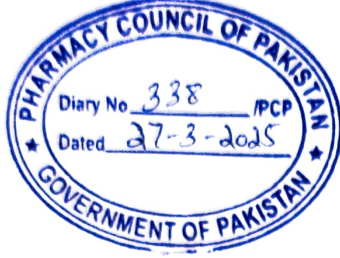

The said Steering Committee has been tasked by the Council to propose renowned experts from all disciplines of Pharmacy (academicians and practicing pharmacists) for the purpose of detailed review of the draft shared by the HEC. The Convener of the Steering Committee may hold online meeting for the said purpose at any date/time, deemed convenient.

Please ensure that name of experts with relevant details (5 for each subject/discipline including one practicing pharmacist, where applicable) must be shared with the PCP Secretariat not later than April 10, 2025 for approval of President PCP after which a consultative session shall be held in 3rd week of April, 2025. The reviewed draft shall be shared with the HEC latest by April 30, 2025 for final notification.
